Other Support: Definition

NOT-OD-19-114 NIH reminder

"Other Support includes **all** resources made available to a researcher in support of and/or related to **all** of their research endeavors, regardless of whether or not they have monetary value and regardless of whether they are based at the institution the researcher identifies for the current grant."

This includes:

- Active, Pending, and Completed within the past three years
 - Including institutional and pilot awards
- Consulting related to research
- Appointments and Affiliations with other organizations
- In-kind resources, including externally-paid researchers or scholars



Timeline

- Note that while the new format and certification are not required until January, 2022, the <u>information</u> is required now, under all formats.
- Additionally, NIH may require use of the new format now for Just-in-Time requests.

Gift or Grant?

- Per NIH, gifts are "resources provided where there is no expectation of anything (e.g., time, services, specific research activities, money, etc.) in return."
- A grant/sponsored project would be something with a defined scope of work, specific aims or milestones, require formal reporting, and involve specific terms and conditions.
- OSPA can assist with these determinations as needed.

In-kind Resources

Components:

- Summary of support
- Source of support

Examples:

- Financial support for laboratory personnel
 - EX: Institution is supporting postdocs to assist in the investigator's research
- Provision of high-value materials not freely available
 - EX: A collaborator is providing the investigator with samples, data, or mouse lines not otherwise available



In-Kind Resources, continued

Examples, continued:

- Laboratory space, equipment, supplies, students, or other personnel supported by an outside source
 - EX: A student is working in the investigator's lab but is fully supported by their home institution (foreign or domestic)

In-kind resources for use in the project being proposed must be disclosed in the facilities and resources section at the time of application submission. New in-kind resources for use in the project being proposed identified <u>after</u> submission of the application, must be reported in Other Support.

In-kind resources **not intended** for use on the project/proposal being proposed must be reported in Other Support.

If the time commitment or dollar value is not readily ascertainable, reasonable estimates should be provided.



New Other Support Format and Requirements

NOT-OD-21-073 & NOT-OD-21-110

- Same format for JIT and RPPR
- Format reorganization
- Signature block added and <u>required</u>
- Supporting documentation requirements

Required January 25, 2022

NOTE: While the new format is not required until 1/25/2022, NIH <u>strongly recommends</u> using it now, and retains the authority to require the new format prior to that date for JIT.

All Other Support documents must include the below signature block. Each senior/key person must electronically sign their respective document. A signature "image" will not be accepted.

I am aware that any false, fictitious, or fraudulent statements or claims may subject me to criminal, civil, or administrative penalties.

Other Support will not be submitted without a signature.

RU is evaluating e-signature platforms for institution-wide use.

OSPA is working on an update to RAS-Grants which will enable users to print an OS template (including signature block) for modifications.



Future Requirements: Supporting Documentation

"For Other Support submissions that include foreign activities and resources, recipients are required to submit copies of contracts, grants or any other agreement specific to senior/key personnel foreign appointments and/or employment with a foreign institution as supporting documentation."

- Applies to all senior/key personnel with an appointment, affiliation, or employment at a foreign institution.
- Provide original documents and English copies
- The English copy will be appended to the investigator's Other Support for submission
- Subaward key personnel from a foreign organization should provide supporting documentation only for those foreign appointments not at their home organization. EX: Dr. Jones at University of Toronto should provide documentation for her appointment at University of Lucerne.

Consequences imposed by sponsor

- Withdrawal of PI or other contributors from project by sponsor
- Imposing strict terms and conditions
- Disallowing costs
- Withholding future awards
- Suspending or terminating awards

Immediately contact OSPA for resubmission of Other Support

 If you realize that something was not appropriately disclosed, contact us to resubmit.

Err on the side of disclosure!



Summary

- Current reports should include consulting, appointments, in-kind resources, and externally supported students and researchers
- New template required January 25, 2022, but sponsor can request sooner
- All documents must be reviewed by OSPA prior to submission to the sponsor
- New items to remember:
 - Attestation and e-signatures for Other Support
 - Supporting documents for foreign appointments (including English translations)
 - Effort for current <u>and</u> future periods
